The proposed draft regulations addresses new and revised requirements contained in AB 175, approved at the 2019 Legislative Session. The proposed regulations addresses new registration types of provisional registrations, and temporary registrations, inactive status of standard registrations, establishes professional conduct and standards of practice, defines activities constituting unprofessional conduct, clarifies and revises continuing education requirements, and provides other matters properly relating thereto.
